The school will do its best to:

- ☐ Provide an environment which has been risk assessed in response to the COVID-19 infection.
- ☐ Adhere to the social distancing rules as set out by the Government as much as we reasonably can.
- ☐ Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs.
- ☐ Contact parents if your child displays symptoms of COVID-19.
- ☐ Inform you if staff or children in your child's 'bubble' has tested positive for COVID-19, as this will mean you will all need to self-isolate for at least 10 days.
- ☐ Continue our clear and consistent approach to rewards and sanctions for children as set out in our Behaviour Policy as well as the expectations outlined in this Agreement.
- ☐ Communicate between home and school through notices, newsletters, email and the website.

PARENT

To help my child at school, I know and understand that:

- ☐ If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 10 days as a family, I will get them tested and I will let the school know as soon as possible via telephone.
- ☐ If my child shows symptoms of COVID-19 at school, I will collect my child from school **immediately**.
- ☐ When dropping my child off and picking them up, I will adhere to the 2 metre social distancing rules and I will stick to the allocated entrance and allotted school timings.
- ☐ My child must only bring in items as advised by their class teacher.
- ☐ My child will wear clean school uniform every day.
- ☐ My child will have their temperature taken if they become unwell during the day.
- ☐ I will remind my child about social distancing rules but accept that they are difficult to follow and that my child may not always do this successfully.
- ☐ My child will need to use good respiratory and hand hygiene.
- ☐ I will report my child's absence to the school office if they are not going to be in school.
- ☐ I will inform school if a different adult will be collecting my child.
- ☐ If I wish to speak to a teacher, I will telephone or email.
- ☐ I need to support all staff in their efforts to create an 'as safe as possible' environment during this crisis.
- ☐ (Year 6 pupils only) I understand that if my child walks home alone, it is my responsibility to instil in them the need to go straight home and this is not the responsibility of the school staff.
- ☐ If my child's behavior causes any safeguarding concerns I will immediately be available.
- ☐ I will complete a **Covid Reporting and Return to School for Key Worker Families / Vulnerable Children after Isolating Form** before my child returns to school after isolating.

I will do my best to:

- ☐ Adhere to the social distancing rules in class and in the playground.
- ☐ Tell an adult if I feel unwell.
- ☐ Not bring extra things into school from home, or take things home from school with me.
